# Lufthansa transports relief goods to India

# A total of ten tonnes of medical equipment fly to Delhi on behalf of time:matters

The scheduled flight LH760 from Frankfurt to Delhi has particularly urgent cargo on board these days: On three flights this week, a total of around ten tons of medical equipment is on its way to India. On Thursday alone, 280 oxygen concentrators flew to Delhi. The equipment is part of a larger consignment that time:matters, the specialist for high-volume special logistics, is carrying out on behalf of a customer.

"We see it as our responsibility to play our part in international aid. The dramatic situation in India shows how important it is to transport relief supplies quickly and easily to where they are urgently needed. That is why we
